Disability Insurance, Paid Family Leave, and New/Expecting Mothers New mothers take Disability Insurance leave followed by Paid Family Leave, for example: Disability Insurance 4 Weeks Birth Disability Insurance 6 - 8 Weeks Paid Family Leave 6 Weeks* *You can break up your six weeks of Paid Family Leave You do not have to take it all at once

Family Leave Insurance provides a monetary benefit, not a leave entitlement This program does not give workers the right to return to their job after a period of family leave Your job may be protected if your employer is subject to the federal Family and Medical Leave Act (FMLA) or the New Jersey
